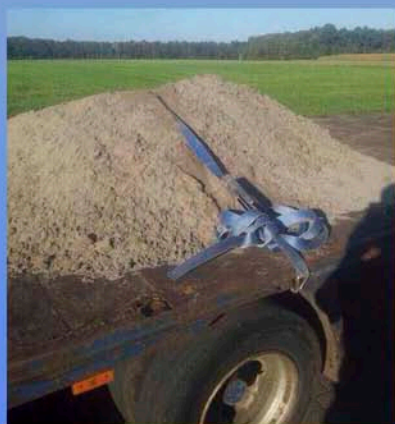
With the AGM approaching that means someone has to step up and take over, in all positions as they fall vacant as of the 19th of May meeting.

PROPOSED AMENDMENT TO CONSTITUTION

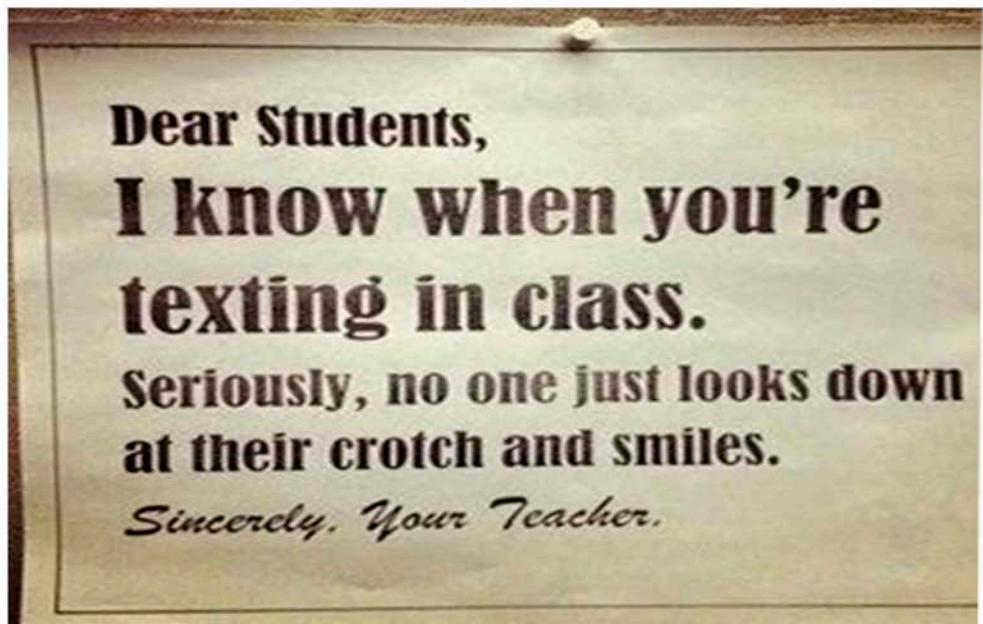
TO BE TABLED AT AGM MAY 2015

Proposed amendment:

It is proposed that the annual membership fee of \$50 per annum be increased to \$60 per annum.

Explanation: Club fees have not be subject to review and increase for more than 10 years. Whilst the club's balance sheet is considered a healthy one it has only been achieved through the success of the previous two annual conventions and vigorous fund raising by conducting 'autokhana" events which are now "out of favour" with members. Over the past 3 years the club has been actively supporting events through subsidies to members. This has only been achieved due to strict financial management of our asset base. With rapidly falling interest rates this capacity is now being eroded.

The committee is of the view that a modest increase is an acceptable and prudent initiative at this time.

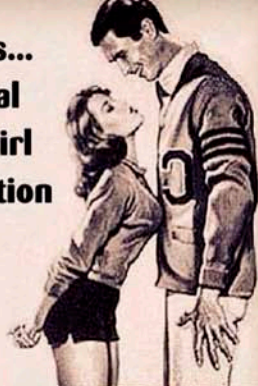

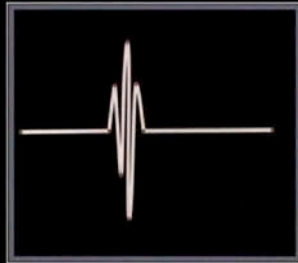

Duties of Committee Members

In order to keep our club running it will be necessary to bring new blood and ideas into the committee. To familiarise members with the roles of the committee it was decided to ask the current committee members to draft a brief summary of their duties and what was expected of them. This current issue of the club magazine has been issued early in order for members, who may be interested in nominating, to read this prior to the A.G.M. If anyone is prepared to nominate for a committee position they can rest assured that they will be guided by current, and past, members.

ROLE OF PRESIDENT:

1] Plan and set Committee and General Meeting Dates

This requires a phone call and booking a date that does not conflict with other clubs using the club rooms.

2] Set an Agenda for these meetings.

Previous business arising to be discussed, acted on by the Committee.

3] Work with each Committee Member and support their Duties.

Being able to work with committee members and resolve any issues that may arise.

4] Promote COWA at all times through our Members, Sponsors, Other Clubs, and the Media.

Talk up the Club at all times, and foster Prospective Members. 5] Minor amount of Public Speaking i.e. welcoming Guests etc.

ROLE OF VICE PRESIDENT:

To support the President and Committee and act as President in the absence of the President.

The Vice President does not have any specific tasks as such except to support the President and Committee in the general running of the club. A basic knowledge of all committee positions is an advantage.

Generally a good candidate for this role is someone who has had past experience with the administration of the club.

Skills required.

Good interpersonal skills with the ability to talk to and listen to members input and comments. Provide feedback to members.

Basic computational skills with access to a computer and email.

Be prepared to attend bi monthly club meetings and committee meetings when scheduled by the President. (When possible)

Comment.

Alternatively this is an ideal way for a member to become active on the club committee with the view to taking on another specific committee role in the future.

The club is always in need of members prepared to act on the committee and is appreciative of new input, ideas, advice and assistance.

A committee position offers a bit more insight into to operation of our club as well as potential contact with other similar car clubs that you may otherwise not have.

ROLE OF MEMBERSHIP REGISTRAR:

1. Receive new applications and enter into club Register
2. Send new members membership card with introductory letter
3. Send renewal notices at end of June
4. Check mail box

ROLE OF TREASURER:

To ensure the management of cash flow in & out of the clubs accounts. This is done via an excel spreadsheet whereby all in & out flows are recorded and balanced against the clubs accounts. The club operates has 3 accounts through the Westpac bank. A general trading account plus has two fixed term deposits.

Tasks

- Banking of cash & cheques
- Payment of club expenses
- Recording of all transactions
- Review of Term deposit accounts. (generally fixed for 3 years)
- Reporting to back to the committee and club members.

Banking:

Trading account: a/c 270072

Banking Inflows:

- Membership renewals (many now done via internet banking)
- New member
- Sponsorship
- Raffles & other fund raisers
- Sale of club merchandise

Sponsors:

Template letters & invoices have been established (are with the treasurer) to post out each June to our regular sponsors. Refer to the club website for sponsors details.

Outflows:

Through the year the club is presented with many expenses that require payments via our trading cheque account # 270072. Each cheque requires 2 authorised signatories.

Payments include things such as:

- CAMs registration
- Insurances & rego for the club trailer
- Yellow pages advertisement
- Postage & website charges
- Make a Wish Foundation
- Hospitality / Club events (mostly incurred by the clubs Social Director)

- Hospitality / Club events (mostly incurred by the clubs Social Director)
- Reimbursement to members who have incurred out of pocket expenses associated with club activities

Fixed Term Deposits

These two accounts tick along nicely without a great deal of intervention. The club generally rolls them over at expiry for a further period at the prevailing rate at that time. The interest earned from these accounts is paid into the trading a/c 270072. As it has turned out the club has been able to function financially and the need to touch the term deposit hasn't arisen.

ROLE OF SECRETARY

- Take the minutes of the general meetings
Once completed sent to President for sign off and on send to Webmaster for placement on the web page
- Collect the incoming mail from mail box and present mail at next meeting.
Reply to any letters following committee decisions regarding action required.
- Attend bi monthly committee meetings
- Provide any general assistance and support to the President and committee in the management of the clubs activities.

ROLE OF SOCIAL DIRECTOR:

1. Set up and oversee the Clubs Social activities.
2. The Social Director is the main Contact for members to make suggestions on social events.
3. The Social Director can ask members for suggestions and help in running events, this gives members a chance to become involved.
4. The Social Director works with the committee and treasurer to make sure all events are within the Clubs financial guidelines.
5. The Social Director has to aim to organize a minimum of 4 major social events each year.
6. The Social Director aims to keep all members happy in all areas Social.

Cruise to West Coast Motor Museum

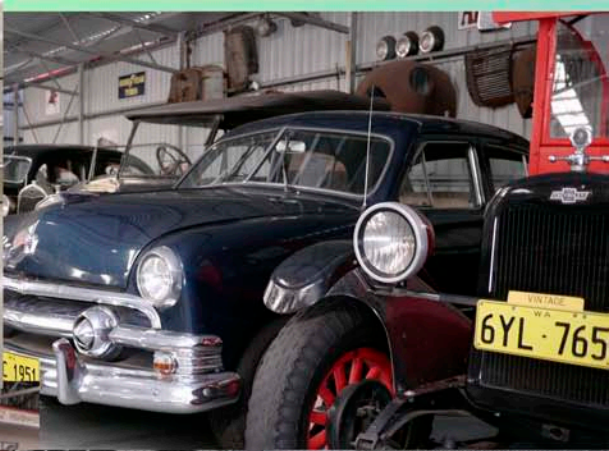
Saturday April 18th 2015

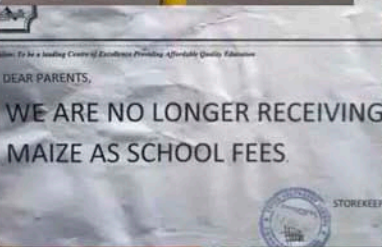
